What is the DCED Standard?

- An eight part framework for effective results measurement.
- Used by 100+ projects in 50+ countries.
- Element five recommends that programmes assess systemic change.



What is systemic change?



An initial definition:

- Change in underlying causes of market system performance that can bring about a betterfunctioning market system.
- Disagreement about what does and what doesn't count as systemic change.
- Poses challenges when auditing systemic change element of DCED Standard.

Where the discussion currently is:

- Three generally accepted aspects:
 - Resilience
 - Sustainability
 - Scale
- One commonly used framework the Adopt, Adapt, Expand, Respond model.
- More work needed to provide examples and arrive at better understanding of what is and isn't systemic change.

Key messages of the DCED Standard

- Think about what you're trying to achieve, and how you hope to get there.
- Consider the assumptions that you're making along the way.
- Gather data to test these assumptions.
- Constantly think back to your original theory, and revise it based on these data.

















Vertical: pilot impact




Illustration of how to use AAER Tool

AAER tool helps to track systemic change through periodic assessment and **feedback** of market players' response to pro-poor innovations.







Illustration of how to use AAER Tool
